ADMINISTRATIVE HISTORY

The Wages for Housework Committee (WFH!), a women's group based in Toronto began its operations around 1973. This committee was a branch of an international organization of the same name. It demanded that the federal and provincial government pay wages for housework. It believed that housework kept women in the home, without financial independence from men. It also struggled against the lower wages women received in paid employment, which also kept women dependent on a man's income. The way in which it wanted to achieve this was through campaigns, in which isolated women could come together and struggle for their causes.

The Wages for Housework Committee of Toronto gathered a large number of articles, pamphlets and newsletters from various organizations. Amongst these were the Wages for Housework Committee from other countries, organizations across Canada and several organizations from the Toronto area. The Wages for Housework Committee of Toronto often attended conferences on women issues and kept themselves aware of the activities of other organizations. They were also active in organizing campaigns and producing articles related to wage issues. Although the date of their demise is not known, by 1986 they seem to have ended.

Prior to Wages for Housework's demise, in the mid 1970's a group of lesbians belonging to the Wages for Housework created a new organization, the Wages Due Lesbians (also known as Wages Due). Their policies were much the same however their emphasis was on the rights of lesbian mothers. Their constitutional difference was that:

"Wages for Housework recognizes that doing cleaning, raising children, taking care of men, is not women's biological destiny. Lesbianism recognizes that heterosexual love and marriage is not women's biological destiny. Both are definitions of women's roles by the state and for the advantage of the state." (Lesbians Organize, Toronto, Ontario, 1977)

The Wages Due Lesbians struggled not only to recognize that housework was work but were demanding the right to be close to other women and free from

servicing men sexually. They also made demands to the government for paid daycare, so that lesbian women could work and keep their children. As with Wages for Housework, they were highly involved in campaigns, rallies and publishing articles on women rights and in particular lesbian mothers' rights. The organization seems to have disbanded by the early 1980's. Before doing so, members from the Wages Due Lesbian created a new organization, Lesbian Mothers' Defence Fund (LMDF).

This new organization was formed in 1978 and focused exclusively on helping lesbian mothers. The Lesbian Mothers' Defence Fund was primarily concerned with helping mothers in child custody cases. As such, it collected a large amount of documents on trials held in Canada and the United States, which it distributed to lesbian mothers or/and their lawyers. It also provided some financial assistance and emotional support to lesbian mothers.

To reach as many women as possible it also began to publish a newsletter, Grapevine: the newsletter of the Lesbian Mothers' Defence Fund as well as Mom's Apple Pie: newsletter, not only did it inform women, the money helped to create a larger organization. The Lesbian Mothers' Defence Fund raised money by holding dances and accepting donations. However, the revenues were slim and they had to rely heavily on grants given by several companies. By 1987 they were disbanded.

CUSTODIAL HISTORY

In 1993, Francie Wyland donated the Wages for Housework, Wages Due Lesbians and the Lesbian Mothers' Defence Fund to the Archives and Special Collections Library as part of their Canadian Women's Movement Archives branch.

SCOPE AND CONTENT

These records provide valuable information on the way in which feminist organizations were closely interconnected and relied on one another for support and information. For example, it is common to find articles, newsletters and pamphlets from the Lesbian Mothers' Defence Fund in the Wages Due Lesbian series. The fonds also contain correspondence with international and national organization, many clippings and some publications by these organizations.

The records are divided into three major series: Wages for Housework Committee of Toronto, Wages Due Lesbians and Lesbian Mothers' Defence Fund. Each series has its own sub-series. Unless otherwise mentioned the sub-series are in alphabetical order.

Series I: Wages for Housework Committee of Toronto (WFH). –1966-1986 – 33 cm of textual material, 1 poster (Box 624-625, HF 43)

The series contains mostly information on other organizations and clippings reflecting the Wages for Housework mandate to unite women under a common goal and to campaign against unpaid housework and low paid employment for women. This series contains little in the way of administrative information. Some items are oversize. It is divided into 6 sub-series listed below:

Sub-series 1.1: WFH - Organization and Mandate. – [1975] – 0.5 cm of textual material (Box 624)

This sub-series contains a mandate outline and a statement of political differences with the Wages for Housework Group I. This sub-series is organized by the by the importance of content.

Sub-series 1.2: WFH – Conferences. – 1975-1977. – 4 cm of textual material (Box 624, HF 43)

This sub-series contains agendas and correspondence referring to conferences attended by members of the Wages for Housework. Some items are oversize.

Sub-series 1.3: WFH – Correspondence. – 1977-1979. – 1 cm of textual material (Box 624)

This sub-series contains correspondence with other Wages for Housework as well as correspondence with Mannie Gorza.

Sub-series 1.4: WFH – Other Organizations. – 1973-1980. – 15 cm of textual material, 1 poster (Box 624, HF 43)

This sub-series contains general information on Canadian, international and local organizations such as reports, leaflets, clippings, newsletters and correspondence. Includes the Family Benefits Work Group and Nellie's Women's Hostel and the Wages for Housework International Network Newsletter (1975), The Other Woman: newsletter and Mother's Money Special Bulletin Newsletter (1978). Some items are oversize.

Sub-series 1.5: WFH – Outreach. – 1974-1979. – 3 cm of textual material (Boxes 624-625, HF 43)

This sub-series contains clippings, booklets, articles and pamphlets on Wages for Housework Toronto on its campaigns and issues. Includes the Grapevine: newsletter of the Lesbian Mothers' Defence Fund (summer 1979). This sub-series is organized chronologically. Some items are oversize.

Sub-series 1.6: WFH – Clippings. – 1966-1986. – 9.5 cm of textual material (Box 625, HF 43)

This sub-series contains mostly articles and clippings on various subjects such as abortion, family law, prostitution and welfare. Some items are oversize.

Series II: Wages Due Lesbians (WDL). – 1963-1984. – 40 cm of textual material, 2 posters (Box 625-627, HF 43)

This series contains mostly published material by the Wages Due Lesbians and from other organizations reflecting their mandate of informing women on the rights of lesbian. The name Wages Due Lesbians has been abbreviated to WDL for the purpose of this inventory list. Some items are oversize. It is divided into 7 sub-series listed below.

Sub-series 2.1: WDL – Organization and Mandate. – 1973-1977. – 2 cm of textual material (Box 625)

This sub-series contains description of organization, constitution and Wages Due Lesbians' political perspective as well as the activity reports. This sub-series is organized by the by the importance of content.

Sub-series 2.2: WDL – Conferences. – 1976-1979. – 1.5 cm of textual material, 1 poster (Box 625)

This sub-series contains reports, leaflets and clippings on conferences attended by the Wages Due Lesbians.

Sub-Series 2.3: WDL – Correspondence. -1976-1979. - 3 cm of textual material (Box 625)

This sub-series contains 1 file of correspondence with publishers, other organizations and other women.

Sub-series 2.4: WDL – Other Organizations. – 1974-1983. - 12 cm of textual material, 1 poster (Box 625-626)

This sub-series contains liaisons with other organizations including the Lesbian Mothers' Defence Fund such as correspondence, articles, flyers and other material.

Sub-series 2.5: WDL – Outreach. – 1976-1980. - 2 cm of textual material (Box 626)

This sub-series contains speeches given at rallies including those to stop Anita Bryant's Crusade, endorsement for the Family Allowance Protest and for abortion.

Sub-series 2.6: WDL – Publications by Wages Due Lesbians. – 1976-1982. - 3 cm of textual material (Box 626, HF 43)

This sub-series includes various articles flyers and newsletters written by members of Wages Due Lesbians as well as the booklet Motherhood, Lesbianism and Child Custody by Francie Wyland. Some items are oversize.

Sub-series 2.7: WDL – Publications on Various Issues. – 1963-1984. - 16.5 cm of textual material (Box 626-627, HF 43)

This sub-series contains a wealth of information collected by Wages Due Lesbians on various issues from child custody to lesbian separatism. Includes several booklets and articles. Some items are oversize.

Series III: Lesbian Mothers' Defence Fund (LDMF). –1968-1985. - 52 cm of textual material, 2 posters, 23 photographs, 20 negatives (Box 627-629, HF 43)

This series contains mostly clippings and court cases reflecting the Lesbian Mothers' Defence Fund mandate of providing information and emotional support for lesbian mothers involved in child custody cases. They achieved this by creating a source of literature for lawyers and lesbian mothers to consult, such as court cases, Lesbian Mother Litigation Manual and other articles on the subject, which consist of the bulk of this series. Some items are oversize. It is divided into 8 sub-series listed below.

Sub-series 3.1: LDMF – Organization and Mandate. –1978-1979. - 1 cm of textual material (Box 627)

This sub-series contains an interim report, meeting agenda a calendar of events and a list of lawyers and potential therapists obtained by the Lesbian Mothers' Defence Fund.

Sub-series 3.2: LDMF – Liaisons with Clients and Correspondence. – 1976-1983. - 11.5 cm of textual material, 21 photographs and 20 negatives (Box 627, HF 43)

This sub-series contains information sheets on new clients, a questionnaire on the potlucks held by the Lesbian Mothers' Defence Fund and correspondence regarding Grapevine: newsletter of the Lesbian Mothers' Defence Fund subscriptions, other organizations and miscellaneous. Some items are oversize.

Sub-series 3.3: LDMF – Other Organizations. – 1979-1984. - 3 cm of textual material (Box 628)

This sub-series contains mostly correspondence and clippings on other Canadian organizations.

Sub-series 3.4: LDMF – Activities. – 1977-1980. - 2.5 cm of textual material and 2 photographs (Box 628, HF 43)

This sub-series contains leaflets clippings and other materials on activities held by the Lesbian Mothers' Defence Fund such as dances, the Robin Tyler Benefit Show and the Rally Against Anita Bryant. Some items are oversize.

Sub-series 3.5: LDMF – Financial Material. – 1977-1985. - 2 cm of textual material (Box 628)

This sub-series contains grant applications, correspondence and a financial statement.

Sub-series 3.6: LDMF – Publications. – 1977-1986. - 3 cm of textual material (Boxes 628, HF 43)

This sub-series contains issues of the Grapevine: newsletter of the Lesbian Mothers' Defence Fund and Mom's Apple Pie: newsletter by Lesbian Mothers' Defence Fund. Also contains article "Men Loving Boys Loving Men" from the Body Politic: newsletter and the letters to the editor concerning this. Some items are oversize.

Sub-series 3.7: LDMF – Clippings. – 1975-1985. - 16.5 cm of textual material (Box 628-629, HF 43)

This sub-series contains mostly articles and clippings on child custody and lesbian mothers. Some items are oversize

Sub-series 3.8: LDMF – Law Journal Articles and Court Cases. – 1968-1983. - 12.5 cm of textual material (Boxes 629)

This sub-series contains mostly court cases on lesbian Mothers' wanting custody of their children. Also includes law journal articles.

NOTES

Organization of Records: The contents of each series are preserved in their original order. The sub-series has been organized into alphabetical order, unless otherwise stated.

Originals and Reproductions: All clippings have been photocopied on acid free paper, except those that had already been photocopied prior to donation, these are identified in the file list. Originals have been removed and are waiting further processing.

Restrictions: Most documents are accessible. At the request of the donor no last names of people connected with the Lesbian Mothers' Defence Fund, apart from Francie Wyland, are to be made public. However, we have included last names if they have appeared in a public document such as a newspaper. All restricted files are preceded by a red dot. The Archives' staff can provide you with additional information regarding the restrictions for each restricted file.
