

Black activists disclaim the realities of the black woman's personal struggle as WOMAN. There can be no dispute that the present economic system is responsible for the political and economic powerlessness of vast segments of society. However, it is dangerous to conclude of society. However, it is dangerous to conclude from this that until such system is revamped or done away with, the individual should not struggle for his or her own personal freedom. Activists, from the chauvinistic Roy Innis to the militant Angela Davis, would discourage the participation of black women in the mass movement for women's rights. Where does revolution of any kind begin except with the self? And until the woman is **personally** changed, will she ever take the next step of questioning the entire social order and structure of things. In the **Black Woman**, black feminist Toni Cade calls the individual "the basic revolutionary unit." That's where it all begins. For me, feminism was my radicalization. As a black woman, my transformation meant forming a completely new concept of who I am, what I'm worth, and where I ultimately belong. It resulted in my developing a social consciousness and a desire to help change the chaos a

round me. But before I understood the need to work for larger social goals, I first had to understand and face up to the special afflictions I was subject to, not only as a black, but as a female. Since I cannot divorce myself from either my color or my sex, to work toward eliminating one of these oppressions and not the other is a meaningless absurdity.

Black liberation was not the vehicle that worked the radical change in my life--feminist philosophy was. Black women must personally come to recognize the lies and the poison they have been systematically fed, lies that have created the very distorted images they have of them round me. But before I understood the need to

selves--and lies that are still uniquely different from the ones fed to them as blacks. In justifying their opposition to black involvement in the women's movement, some blacks have cited the middle class woman's role as parasite with no traditional relationship to production, in contrast to the black woman's role as breadwinner and 'workhorse.' Some would go so far as to imply that "all white women have it made." But a staggering number of poor white females labored to early deaths in the Man's factories and sweatshops, and in major cities they are doing so today. It is a romanticized version of the middle class white woman's role that so many young black wo-

To the editors
Sisters:

I just received the latest issue of Majority Report with a short article about the women's sexuality conference, held recently in Conn. This conference was devoted to consciousness raising about all the issues relating to women's sexuality. I was therefore shocked that your coverage made no mention of our speakers on lesbianism and prostitution. I know that this was not the fault of the reporter, since I was that woman. Therefore ... an editorial decision was obviously made to delete any mention of these two topics.

Lately, the women's movement is developing a schism between gay and straight women as well as good (lady) vs. bad (prostitute). If we are to succeed in liberating All women ... then we must deal with the above mentioned splits between us.

To me, feminism means 'freedom of choice for All women in a society free from any sex bias.'' ... We in Conn. made a beginning, tentative attempt to deal honestly with some of these issues. .. Gay women and prostitutes were integrated into our conference as sisters. Out of 7 speakers, 3 and maybe 4 were either gay of bisexual. The workshops had gay and straight women discussing many areas of sexual concern, in many cases having nothing to do with sexual preference.

Sidney Abbot, a speaker on lesbianism and feminism, deplored the fact that after conferences, "business as usual" returns and gay women continue to be oppressed. We assured her that we would work to see that this doesn't happen. ... But the report in your paper made it seem as if lesbianism and prostitution weren't even included. So, at least in Majority Report, business did return as usual, ...Neglecting to mention how gay and straight came together, talked and responded to one another, without hassles, constitutes an act of oppression (though perhaps it was an oversight).

Kathy, who spoke on prostitution, evinced warm feelings from the audience; in the workshop, there was no "putting down" of women in prostitution. . There was some sentiment in favor of lega

The success of this conference was due to 1, an extremely supportive atmosphere; 2, integration of all types of women ...with no one group predominating; 3, juxtaposition of all areas of sexuality and all ways women are oppressed sexually . . . The power structure over women was exposed in all its myriad ways of dividing us and keeping us afraid.

I began to get acquainted with my pioneer self when I was eight. I wanted to be Robin-son Crusoe, to stake out wilderness territory and live off the land. I set out more than once pulling my wooden wagon piled high with possessions. It was those very possessions - tins of spaghetti, T.shirts, a rock and a hoe among them, that gave me away; and I was returned home, none too gently.

Having barely escaped the two-car garage and ranchouse, many capable women are too frightened to move ahead. As someone lets out a battlecry for an Amazon Nation of All Big Strong Women, they're likely to stop dead in their tracks. I see pioneer women growing, going into fields where men have always ruled- business, medicine, baseball, the arts.l see her getting together with other women and starting businesses of her own. I see her not masculinized, not feminized, but a woman humanized and humanizing. I hope you know at least one of her.

Some or our pioneers are not members of NOW or Radical-Feminists or OWL or Professional Women's Caucus. Some remain quietly unknown, like the mother in Connecticut who cuts roses from her garden for the guestroom where her gay daughter, on a visit, would sleep with her lover. Some women are pioneers by virtue

"Hail Mary, Mother of Clone

Adam will be created from Eve's egg, within this century and without the assistance of his precious spermatozoa. If this should sound like the freaked out ravings of a reincarnated Amazon, you should also listen to one of the most eminent biologists of our time. The shocking fact is, scientists DO know enough about genetic engineering to have already discovered startling alternatives to the 'normal' sexual reproductive processes, and have assumed an effective slience to keep the general public unaware of asexual reproduction and all its ramifications. This unspeakable threat to the Foundation Of Life As We Know it is generally referred to as clonal reproduction, and is a subject important enough to merit a lengthy study, 'The Future of Asexual Reproduction', by Nobel laureate Dr. James D. Watson, professor of molecular biology at Harvard and discoverer of the DNA 'Double Helix'.

OXFORD FROG

Clonal reproduction is the process by which animal progeny are generated WITHOUT the union of a haploid sperm cell with a haploid egg, which gives higher animals a mixture of maternal and paternal genes. Several years ago, at Oxford, a frog was produced by cloning - the nucleus from a frog's egg was removed and a diploid nucleus from the intestinal cell of an adult frog was inserted in its place. Microsurgical removal of the maternal nucleus from this egg had also removed its genetic material. When the egg gained the diploid nucleus (not the haploid nucleus of the sperm), it acquired the chromosome number normally present in a fertilized egg, thereby being activated to divide (mitosis) and pass through all the embryological stages which culminate in an adult frog. The Oxford frog derived ALL its genetic material from the frog whose intestinal cell was used as the nuclear donor, and the genetic makeup of all its diploid somatic cells was identical to that in the donor frog - in fact, it was an identical twin. A clone, to be precise (the asexually produced progeny of a single cell).

TEST-TUBE KEWPIE DOLL?

TEST-TUBE KEWPIE DOLL?

This very important scientific event means that, theoretically, all forms of higher animal life, including 'Man', may be capable of clonal reproduction. But clonal reproduction of human beings has seemed, to most geneticists, to be so unlikely that it isn't worth stirring up public attention. Their beliefs rest on the fact that there are fundamental embryological differences between amphibians and mammals. The amphibian's development occurs IN VITRO, outside the female parent's body; the unfertilized egg contains all the food supply necessary to reach the 64-cell (or blastocyst) stage, when it transplants itself on the uterus wall and placental formation occurs. All the stages of mammalian development occur within the ovary, oviduct, or uterus. Despite Huxley's Brave New World vision of test-tube kewpie dolls, there seems to be no real prospect that mammals can ever be raised totally IN VITRO. And, at this point, micromanipulation techniques for nuclei insertion cannot be applied to mammalian eggs, as they are likely to be damaged by the insertion of a nucleus whose diameter is almost as large as the egg itself. Obviously, these factors make mammalian experimentation very difficult if not unlikely, and the pace of research on human reproductive biology has been slowed down by these factors. 'With a few exceptions', says Dr. Watson, 'work on the early developmental processes in Man has not been seriously pushed either here in the United States or elsewhere.'

MICKEY ('THE CLONE') MOUSE?

Though unknown even to most blologists, research on the in vitro cultivation of mammals has already occurred. Techniques ARE available for the isolation of mouse eggs, their fertilization in vitro, and test-tube cultivation to the 64-cell stage. The blastocyst can be inserted into the uterus of a living mouse, where it can develop to normal birth. Most of the techniques needed to produce a clonal mouse are already available; the remaining obstacles are the removal of the haploid maternal nucleus (enucleation) and the subsequent addition of a diploid adult nucleus. But another method may be used for the enucleation process - a mitotic polson known as colchicine, when added to pre-ovulatory mice, leads to unusual meiotic divisions and nucleus-free eggs. Healthy, enucleated eggs can also be produced in vitro with this same chemical. And furthermore, nuclear insertion may not be so tricky, after all. Simple methods have been developed for the fusing of two cells to form a single cell containing the genetic traits of both donor cells. The introduction of Sendai virus (relative of the common flu virus) modifies cell surfaces, and when two treated cells touch each other, the opposing cell surfaces dissolve,

Christopher Graham, also at Oxford, has been using Sendal virus to fuse mouse eggs with diploid adult mouse cells. These fused eggs can divide several times, but have not yet developed into biastocysts. Dr. Watson feels, however, that Graham's efforts will succeed and the clonal mammal will no longer be science-fiction.

CLONING FOR PROFIT

The most likely group of scientists to pick up on cloning would be veterinarians. They know very well the exorbitant prices paid for prize animals, and animal husbandry may lead the way in clonal research. It is ironic that such painstaking scientific endeavors should be prompted by the ubiquitous profit-motive rather than the imperative need to explore 'Man's' genetic future (i.e. probing the human reproductive process so that better contraceptive methods can be obtained). But, it seems virtually inevitable, that the number of human embryogeneticists will greatly increase, and direct experimentation with human eggs will be involved. No doubt there will be hysterical reaction among some parts of the general public, particularly among those with strong religious backgrounds. Nonetheless, 'if the matter proceeds in its current non-directed fashion, a human being - born of clonal reproduction - most likely will appear on earth within the next twenty to fifty years' predicts Dr. Watson.

FEMINISM AND THE NEW 'C-R'

The first human clone will be greeted with dispair if not outright denunciation; for clonal reproduction may mean the eventual dissolution of the Nuclear Family, and a radical change in everyone's values about her/his individual uniqueness. And, Shades of Minerva, the male-chauvinist myth of the Supreme Sperm being indispensable for 'Man's' reproduction will be shattered for all timet. Mighty misogynists such as N. Mailer will have to face grim reality and realize there is no 'male imperative'. The issue of spontaneous conception would have to be pulled out of the closet once more and be scrutinized under a new light. One could almost savor with delight the dilemma faced by the Roman Catholic Church: How can it denounce clonal reproduction while at the same time it has offered the only physical proof for the validity of the 'Virgin'. Mary?

MYRIADS OF MAILERS AND WILLERS

MYRIADS OF MAILERS AND MILLERS

If the female chauvinist in us is now beaming with unbridled joy at the prospects, let us enjoy it for this moment only - for a new male backlash will inevitably be launched. Consider these facts: MEN have developed the research and developed the tools for clonal reproduction; the vast majority of the technicians in this field are MEN; MEN are not advancing in their research to prove they are DISPENSABLE in human reproduction; indeed, MAN Is well on his way to securing permanent control over WOMAN for the benefit of HIS genetic destiny. Man will create Man IN HIS OWN IMAGE. One need not be a devout Roman Catholic to shudder at the thought. The manifestations of Man's fantasies would know no boundarles should clonal reproduction become his newest toy (for boys only, naturally). We might as well envision myriads of Richard Milhaus Nixons, Pablo Picassos, Leopoid Stokowskis, Muhammed Alis, Spiro Agnews, Jonas Salks, Henry Millers, Hugh Hefners, Raquel Welches, Anita Ekbergs, and Al Capps. We can also envision a new form of oppression for ourselves, the bribed Surrogate Mother. This institution could easily rival that of Prostitution, and a new, economic alternative for women would filing open its doors. Selective cloning COULD be the utilmate method for keeping women 'barefoot and pregnant'. Behind the guises of seemingly altruistic genetic research, under the velled promises of population control and 'a woman's right to choose' lurks the master manipulator,

tion control and 'a woman's right to choose' lurks the master manipulator, the Male Ego. 'The potential for abhorrent misuse should not necessarily weigh more strongly than the unhappiness...married couples feel when ...unable to have their own children,' states Dr. Watson. We may regard this carefully as the first of many veils. Let us dearly hope that most scientists do not plummet to Mailer's Neanderthal level of consciousness, where he 'can never understand that a woman is not simply a creature to be used for breeding...'

It must be in this century, then, that women must struggle and FIND their own strength to achieve not only their equality, but their own bio-

It must be in this century, then, that women must struggle and Find their own strength, to achieve not only their equality, but their own biological ADVANTAGE. Women must be in the forefront of clonal research, and feminists must participate in any legislation pertaining to cloning. Women's equality will not be enough to stave off the eventual consequences should MAN acquire the genetic key to his permanent, IRREVOCABLE dominance.

N.J.: ARE 2 HEADS REALLY BETTER THAN 1?

NOW to reorganize its chapters on a statewide level apart from the joint feminist Statewide Coordinating Committee has been causing some friction within the N.J. women's

Union Theological Seminary is undergoing a baptism by feminism. Its Board of Directors recently voted to require that students, faculty, staff and directors be one third black and 50% female.

Women are now 20% of the students and board and 8% of the faculty.

planning group, said the seminary would play an 'advocacy role' for women's rights in the churches. She predicted that women would develop new forms of ministry. 'Women aren't as reliant on status symbols like the collar and "the Rev." before the name,' she said.

ment emerged in New Jersey only three years ago, consisting of county chapters of the National Organization for Women. These NOW groups started a Statewide Coordinators Board two years ago to facilitate statewide activities of NOW.

About a year ago two other women's groups were formed in the state, Alliance of Women for Equality and Daughters of Bilitis, a lesbian group. Both groups were soon made part of the coordinators board. Participation continued to expand until the board, now called the SCC, in cludes WEAL, POWER, WPC/NJ and GAANJ Women.

The advocates of a seperate superstructure for NOW seem to be a minority of that group. Their argument is that by organizing on a statewide level, NOW would be strengthened, and what's good for NOW is good for the women's move-

Opponents of the second coordinating board reason that whatever the shortcomings (if any) of the current structure, it is ludicrous to think that expending energies

to build a new structure, only to have to expend more energies to achieve the desired end, will be more effective than to expend energies toward the desired end in the first place ... within the existing structure.

Some of the questions being pondered by New Jersey feminists are: Is the second structure a step forward or a step backward for the success of the movement? What's more important -- a stronger NOW or a stronger feminist coali tion? Should NOW seek power at the expense of rapport with other groups?

An editorial in the Lazette, DOB NJ's newsletter, warns against putting NOWhood above Sisterhood.
"DOB NJ does not care under what 'name' women's rights are won. DOB NJ does care, however, that NJ Lesbians have proper and significant representation in all phases of the women's movement."



When closed out of the women-only WONAAC conference at Hunter July 15-16, birth control crusader Bill Baird won much fanfare in the media by throwing himself repeatedly against the building's glass doors. He said he would sue the Women's National Abortion Action Coalition and Hunter

Raiss goors. He said he would sue the Women's National Abortion Action Coalition and Hunter College for discrimination, but actually in threatening to castrate him and telling him to 'go have an abortion and come back', the WONAACwomen were saving him a tremendous waste of time.

Those of us not handicapped by being of the oppressor class were subjected to two hours of proposals, counterproposals, amendments, points of order, and obfuscating points of clarification for the conference participants to agree upon an agenda. Thereafter, things were far, far behind. The some 800 women enduring the conference found their brains being bombarded with heavy raps about WONAAC's pop-frontism, tailism, bour geois reformism, and Socialist Workers Party domination. Women who sought temporary escape in the lobby were besieged by flutters of mimeographed anti-WONAAC position papers from such groups as Youth Against War and Fascism, the International Socialists, the Sparticists, and even WONAAC coordinators. The thing was even duller than the first two WONAAC conferences even though a wider spectrum of groups came to trash.

For those who haven't yet waded through the mass

For those who haven't yet waded through the mass of published criticism, let us summarize the basic disputes:

1) The influence of SWP and its youth arm, the Young Socialist Alliance (YSA) in WONAAC. The objections to SWP are based on its refusal to lobby, or participate in electoral politics, and its reliance on a single tactic of mass marches, which many women believe is inadequate for the abortion issue. Some feminists feel that WONAAC should be free of domination by any political party. Leftist women's groups

believe is inadequate for the abortion issue. Some feminists feel that WONAAC should be free of domination by any political party. Leftist women's groups criticize WONAAC for making coalitions with bourgeois groups.

SWP claimed to be in the minority at the conference, but obviously controlled a bloc of well over half the women there. The party won on every point, all hands snapping up simultaneously on each vote. This phenomenon was rather depressing to those women who were under the impression they were there determining the course of WONAAC. Several first timers swore they'd never have anything to do with WONAAC again and proceeded to fade away.

Not all dissenters were content to bitch in the back of the hall. During Sunday's plenary, Nancy Rolfe, a non-SWP national coordinator, won the mike and gave a resignation speech that was sharply critical of the way SWPI was controlling WONAAC. She was followed by fellow travelers Judy Syfers, Ann Davidson, Joan Gombos, Vicki Esslinger, Terry Bruce, Rose Weber, and Ellen Shapiro, each a member of WONAAC's central cabinet.

The dissidents opposed the current composition and direction of WONAAC. Syfers and Gombos felt that WONAAC's focus was narrowing, and that it should broaden its efforts to work with other women's groups. Bruce criticized the WONAAC staff for backing away from lobbying and educational programs, and for 'talking to ' and ' manipulating' indemendent women.

Weber and Shapiro spoke of their frustrations in working with SWP and YSA members who would not 'listen to differences'. All the women pledged to work in other parts of the abortion movement.

Predictably, the criticisms were dismissed 'red-baiting' by one SWP spokeswoman,

3). Advocates of total repeal of abortion laws vs. supporters of compromise legislation. The debate on this issue was, to quote Alice, 'a very curious thing'. Under a neatly lettered banner proclaiming WONAAC's intention to 'repeal all anti-abortion laws' (are there any pro-abortion laws?), the plenary voted to refaffirm WONAAC's demand to repeal all abortion laws

A few minutes later, a motion submitted by Cindy Cisler of NOW, et. al., that WONAAC refuse to support any reform legislation in favor of total repeal was rejected. So WONAAC supports total repeal and reform, as in New York and Michigan, as a first step toward

as in New York and Michigan, as a first step toward repeal. This decision puts WONAAC to the right of NOW which holds that reform measures are compromises tending to retard the effort for true repeal.

4). Tactics, SWP rejected a national educational campaign on ending forced sterilization and the right to voluntary sterilization. It was also against the suit lodged against the Catholic Church's lobbying action while markinging a tax years taken. And it was while maintaining a tax-exempt status. And it was against lobbying, as usual.

What the SWP women wanted was an international tribunal on abortion crimes, to be held sometime in the fall, and to be followed with by a (guess what?)

mass march.

WONAAC calls itself the only national coalition of pro-abortion organizations. But while 'prolife' forces are picking up support from the Catholic
Church, right wing groups, and Richard Cardinal Nixon,
WONAAC calls for an expensive, but powerless tri-WONAAC calls for an expensive, but powerless the bunal and another national march. Proposals that the huge sums of money needed for both these actions be spent instead on bail for those who are directly challenging local laws, and state-by-state efforts to overturn the laws, were defeated. Local organizers ple aded with WONAAC not to hold the tribunal, feeling it would divert their energies from the local struggles. Others feared that women would be jeopardized by public testimony. They were overruled, and WONAAC embarks on another self-glorifying action.

As an alternative to the current disunity to the abortion movement throughout the United States, Cindy Cisier proposed a 'Committee of Correspondence' for communication among various local action groups. The Future of WONAAC

Dial M for **Menstrual Extraction**

Merle Goldberg didn't sleep much Thursday, July 13. As executive director of the National Women's Health Coalition ("a loose federation of feminist health activists") her phone number had been printed that day in a Post article about a "New Technique for Abortion." Her phone rang all that night, and by the time an official press conference to introduce the "new" technique (which has been unofficially around for a few years) had been held, she estimates she had been getting at least 200 calls a day.

few years) had been held, she estimates she had been getting at least 200 calls a day.

Women, interested in the technique, called menstrual regulation (a.k.a. period/menses extraction, "instant period," endometrial aspiration, vacuum aspiration) are being referred to the Project for Reproductive Health in Brooklyn Heights, 186 Remsen St. (237-0400) and a clinic in Long Island City - Roberts, Roseff and Berk 29-28 41 St. (249-7312. By September there should be many more clinics - some hopefully will charge less than the current rate of \$30. All clinics recommended by the Coalition have been carefully screened and Merle Goldberg has insisted that training sessions must be conducted for all doctors involved.

The procedure involves the introduction of a 4mm cannula into the uterus, through the vagina - which requires no cervical dilation. Suction is then applied which results in the removal of the menstrual lining and anything else that might be there (i.e. a fertilized egg). The practically painless procedure takes just a few minutes to perform and can be done at any time within 10 days of a missed period.

Dr. Charles Birnberg of the Brooklyn clinic, which started doing menstrual regulation July 14 (he prefers the term "endrometrial aspiration") explained to me which women are not candidates for the procedure. Any woman whose uterus is enlarged, softened, or who has a color change or who has a positive pregnancy test is not able to use this technique. Dr. Birnberg cautioned women to be prepared to be turned down for the procedure if they are not eligible - in which case they are "put on an abortion program" - which causes the price to rise to about \$150.

One point to be stressed is that, according to many authorities, menstrual regulation is not the same as an abortion - it is done before pregnancy has been established, but when it is suspected. This is medically a "gray area" and legally puts the technique in the same category asolther morning after pill and the IUD.

expose male bias in nominations for n.y. high court

A news release was issued on July 31 by NY NOW, New Women Lawyers, Doris L. Sassawer of the Professional Women's Caucus, and Stanley Geller, Chairman of the Committee to Reform Judicial Selection. The following are some excepts from their plants. cerpts from their charges:

cerpts from their charges:

We deplore the Democratic Judicial Delegates' failure to nominate any women to run for the State Supreme Court on the Democratic ballot in November. With 13 nomination spots open, the three judicial conventions chose 13 men to run in Manhattan, the Bronx, Queens and Brooklyn, ignoring the recommendations of Stanley Geller's Judicial Reform Panel. Three out of the 12 candidates recommended by this panel were women: Mary Johnson Lowe, a black Criminal Court Judge of exceptional ability; Marie Lambert, a Manhattan lawyer with broad civil practice and a well-known criminal lawyer; and Irma Santaella, a Puerto Rican and a Commissioner on the State Human Rights Appeals Board.

We place particular blame for the conventions all-male choices upon the regular Democratic party which dominated the convention and which repeatedly reached its decisions by the usual process of trade-offs, deals and high-pressure tactics. It is widely reported that Pat Cunningham, Bronx County leader, pressured the Rossetti screeening panel into nominating Burton Roberts, the Bronx D.A., after they had first refused to find him qualified. And it is also widely reported that Judge Mary Johnson Lowe was the "sacrifice" candidate to Burton Roberts' candidacy. The Democratic regulars told their favoted male candidates in advance to ignore the independent bipartisan Geller committee. The result: the favored

the independent bipartisan Geller committee. The result: the favored males got the nomination and the women candidates were ignored.

The women's organizations are so irate at the results of the Regular Democrats' selection of an all-male slate, they are threatening to run an independent slate which would include a fair representation of women.



On her wedding day my grandmother died --legally, that is. Her husband had a right to her property, represented her at the polls, and had guardianship of their children. He could chastise her physically and require her to live in a place of his choosing. She had no recourse under the law. Our laws derive, mostly, from the English common law, and under common law, a woman became 'consolidated and incorporated' with her hus-



band on the day of her marriage. She no longer existed as a person.

Many years have passed since then and things have changed, but not as much as you might think. Not until June of 1970 did the legislature of Louisiana get around to ratifying the 19th amendment (woman suffrage) which has been part of our Constitution since 1920. The Civil Rights Act of 1957 made it possible for women to serve on federal juries in all states, but only since 1968, when Mississippi amended its law barring women, were they able to serve on on state juries in all states. Today, in 28 states women serve under the same terms as men, but in 22 states and the District of

Columbia women are excused for reasons not permitted to men. In 11 of the 22, a woman may be excused simply because of her sex, while Louisiana requires her to regis-ter before even considering her for jury duty.

Many legal rights and duties attach to a person's domicile such as voting, running for office, jury duty and paying taxes. In all but 14 of our states a married woman's domicile is that of her husband, and she is obliged to follow him if he makes a change. Of the 14 exceptions to this law, only 5 permit her to have a seperate domicile for all purposes.

Marriage and divorce laws are different for men and women. Forty-eight states and the district of Columbia permit the awarding of alimony to the wife. A few states permit alimony to either spouse. In all states a husband is responsible for the support of his wife, and in most states she is sponsible for his support if he is unable to support himself. Both parents are responsible for the support of a 'legitimate' child, but an 'illegitimate' child is the mother's responsibility.

Most of our states have derived their

property systems from the English common law, but there are 8 which use the community property system derived from French and Spanish law. Earnings are considered part of the community property which is managed by the husband. However, 4 of these states have recently made provision for a wife to control her earnings.

In three of our states a married woman cannot become a surety or guarantor, and in four others she needs court sanction or her husband's permission to engage in an independent business. One state requires her to file a certificate to prevent her business property from being liable for her

husband's debts..
Until the Equal Rights Amendment is ratified by 18 more states, to bring the total to the necessary 38, there is no reliable basis for challenging state laws which discriminate against women (and



Essex County NCW filed a complaint with the N.J. Civil Rights Division in her behalf on the basis of discrimination in public accommodations. However, because her parents, who are under intense pressure not to bring discrimination charges, did not file as aggrieved parties, the girl could not be reinstated on the team for the rest of the season. However, the Division of Civil Rights will file its own complaint against the Little League Organization. The Atlanta, Ga., NOW Chapter is also going to bat for a would-be sportswoman, and both groups are expressing the hope that nation-wide action will bring to a half the League's all-male

a review of GROWING UP FEMALE IN AMERICA: Ten Lives, Edited and introduced by Eve Merriam. Doubleday. 308 pp. \$7.95

The women speak of isolation, the aloneness that is at the depth of being in this collection of writing done by women in America beginning from the early eighteenth century.

At a time in history when revolu-tion enflamed the passions and revo-lutionaries preached strong develop-ment of individuality in men and nations, women too inquired into their own beings, to that place where the uniqueness of each is perceived. What happened, what is the record, where is it ... A woman may be ahead of her time by the simple expedient of objecting to a condition a hundred years prior to history's objection. It is instructive to reread Mary Wollstonecraft and, for that matter, John Stuart Mill, on the woman question. Today we are timid by comparison.

Ten lives are included in the first section of GROWING UP FEMALE IN AMERICA. Eve Merriam has brought together diaries, letters, auto-biographies and transcripts told in the first person. Most of these lives are uncelebrated. While Elizabeth Cady Stanton achieved reknown as the founder of the suffragettes, "Mother (Mary) Jones" became a labor organizer, the New England schoolgirl in this book died at age 25, the astronomer, the Confederate officer's wife, the slave, the Jewess, the Winnebago Indian and others led lives defined largely by their relationships, their individuality subordinated to their roles of daughter, sister, wife, mother or spinster. There is gratification in reading these pieces, as well as pleasure. Most of these accounts have had previous publication but are out of print.

Be amused by and then cheer Eliza Southgate, born 1783, when she says in a letter to her cousin in 1800 that she hopes she has the firmness to brave the sneers of the world and live like an old maid. Like George Eliot, she later more seriously perceives that the business and pursuits of men require deep thinking, judgment and moderation. The lack of such demands on the intellect of women causes females to lose the strong energetic qualities, become enervated, impaired and causes them to at last die for want of exercise. She does marry, a Mr. Bowne. Her mood changes to one of underlying despair. She writes that she cannot respond when old acquaintances call her Mrs. Bowne; it makes her stare -- it sounds so odd. Four children later, she begins to ail. When she is sent to South Carolina by her husband for the winter of 1808-09, he writes to her:
"To Mrs. Bowne.

I hope you have a comfortable place now; what abominable lodgings the first were. Don't mind the expense; get everything you like, we can afford it."

Too late, the woman was dead before

the year was up.
Mountain Wolf Woman, a Winnebago Indian born in 1884, accepts the man her brothers choose as her first husband because her mother tells her that once she has had a first husband and leaves him, she is free to choose any subsequent mate she desires.

Elizabeth Gertrude Sterne, born 1890, refuses to marry any man her father and aunts choose for her, preferring happiness, a concept new to her Jewish parents. Her puzzled father points out that she has a good home; that her mother and he have been good to her, and asks her, as Sigmund Freud was to ask of all women, what it is she wants. He blames himself-for having allowed her to go to high school in this new land, now she wants to go to college Yet Elizabeth wanted to live and act according to a faith she had, just as her father wanted this for himself. He could not understand that, and never communicated with her again after she left his

nome for advanced study, work and marriage. Mrs. Sterne in her autobiography I AM A WOMAN AND A JEW says that, in 'that inner self that cannot change,' she belongs to her people. Her life, she reiterates, is but an atom of their long history

The section called The Attic includes documents and dictums, the adages with which the minds and psyches of little girls were bombarded --"Little girls should be seen and not heard," to which saying my own father was much addicted in his relations with his daughters. A FEW RULES OF ETIQUETTE States that little girls in the 1700's were not to sit at table until asked that they were to ask for nothing and not to

speak until spoken to.
The creativity of women in these centuries went into letters and diaries, as here collected. More often their work in these relatively silent centuries, went into drawers and fires. Women themselves were the worst offenders, often burning by some Kafkaesque urging, their own work. Daughters burned their mothers' work. Relatives destroyed it to keep reputations of families unsullied. Omissions too, make for historical lies.
Those mad beings! Strange solitaries like

Emily Dickinson and the Bronte sisters who wrote, we are told out of nothing. At most, people such as Dickinson and the Brontes had one or two distant meetings with the men of their imaginations, and we are led to believe, spent the rest of their lives isolated, weaving the tremendously strong and real works that found their way into print and the critical appraisal of the mainstream of literature.

GROWING UP FEMALE IN AMERICA gives a history and background, presents the rich and dynamic culture and models and circumstances, the substantial ideology which was alive and fomenting the lives of women and men during our country's early history.

Dateline, Rome: 'The Pope announced today that she...' Why not? Because women are barred from becoming cardinals, archbishops, priests, orthodox rabbis and, with few exceptions, deacons in the major faiths. Women are permitted to teach Sunday school, hold cake sales, and operate bingo games.

Religious feminists in Manhattan have organized a series of four seminars to explore anti-woman attitudes in religious hierarchies and to develop strategies to challenge this systematic exclusion of women. The feminists hope to raise the consciousness of church-going women. They will also support and encourage women who are aspiring to the higher orders or 'professions' within the faiths.

Activist religious womens' groups are growing throughout the nation. Sister Margaret Traxler and her community of nuns recently issued a 'declaration of independence' from the male-dominated Catholic faith. Mary B. Lynch, a scholar with three Ph.D.s, is studying for the priesthood. Boston's religious activists are thinking of creating a separatist 'Feminist Church'. Women are studying the Bible and the Talmud and their interpretations are far different from the traditional male view. Women's caucuses have been organized in the lay associations.

The Manhattan group is part of this national movement, and the speakers for their seminars are women who have broken through discriminatory barriers in organized religion. On July 11th, Dr. Julia Sibley, Chaplain of New York Hospital, described her ten years of courageous struggle which led to her recent ordination as the first woman deacon in the Episcopal Church, U.S. Professor Beverly Harrison of Union Theological spoke on July 25th. Frances McGillicuddy of the St. Joan of Arc International Alliance will speak on August 8th and a woman from the Jewish faith is scheduled for August 22nd.

The seminars begin at 6:30 P.M. at the Church House of the Madison Avenue Presbyterian Church (73rd). Attendance is limited to women.

Religious women are expressly invited. Even if you are not a believer, the meetings offer historical knowledge about women in religion as well as the opportunity to talk with our

Fest's 'Right-to-Life' Church Challenges Film



The Albany Area Chapter of **NOW** planned to create a stir with its Women's Film Festival held July 21 and 22. What happened instead went beyond the simple presentation of feminist movies; what occurred can only be called a major confrontation between the canons of the Catholic church and the ideologies of the Women's Movement.

The film festival was to be held at the Calledon of St. Peso in Albany and

The film festival was to be held at the College of St. Rose in Albany and the Renssealaer Polytechnical Institute Chapel and Cultural Center in Troy. Instead, it was held at the Emmanuel Baptist Church and the McNeil Room of

the RPI student union.

The films themselves were not the target of the attack by an editorial in the **Evangelist** (the Albany Diocese weekly newspaper, and supported by local Right-to-Life groups). The issue was whether **NOW**, which advocates the repeal of all abortion laws had the right to use the scheduled facilities.

The Evangelist editorial was a low key argument on the inconsistency of any Catholic organization allowing its building to be used for fundraising by a pro-abortion group. (Curiously, St. Rose is now considered by the State of New York Education Department as a non-sectarian school for the purpose of receiving financial aid for its higher education programs.

The Right-To-Lifers were not so subdued. On Wednesday they made over 125 calls to the C.C. center, making threats of civil disturbances during the performances and physical violence to the building, including bomb threats. It seems the Right-To-Life people have just discovered techniques long

abandoned by other militant groups as fruitless.

The film festival continued as planned and was a financial success for Albany NOW. This distasteful Right-To-Life display has served not only to alert the Women's Movement as to the nature of the next legislative session on abortion, but it has also given a rallying point for the coalition of feminists, ZPG, and Planned Parenthood advocates.

St. Rose, a Catholic college, certainly has the respected right to make a

decision regarding its stand on abortion. However, it is not entitled to use our money (\$211,000 in public funding) to proselytize any tenet not commonly held by all N.Y. taxpayers. There is strong support from many Catholic women, including nuns, that this issue can only be decided by the individual Isn't it time that Bishop Broderick of the Albany Diocese heeds the voices of ALL his flock?

The Pill is dangerous, foams and condoms unreliable, diaphragms a bother and safe abortion unobtainable in most states. Sterili-zation, according to author Fried, is a possible catalyst for serious disease, especially in men.

Fried says that men are rushing or being pushed by anxious wives to have vasectomies with out really knowing if they are safe. He likens the situation to giving women the Pill without adequate research. He also points out, that a lot of vascetomised males are suffering more than jock itch from the procedure. This is be-cause many doctors view vasectomy as a moneymaking opportunity and are doing them without proper know-how.

The most serious charge Fried makes is that

vascetomy may affect the male's immunologic system. There is evidence that the blood streams of more than 50% of sterilized males con tain antisperm autoantibodies. The antibodies appear in only 2% of 'normal' men. (Apparently, Fried considers vasectomized men abnormal.) In monkeys the level of anti-sperm autoantibodies rises each year after sterilization. Whether thi also applies to humans must be investigated.

It is not clear what all of this means in terms of endangering men's health. Autoantibodies are defenses the body creates against itself. In vascetomized men, the antibodies develop to fight the sperm which goes into their bloodstreams instead of being ejaculated. Some diseases possibly linked to autoantibodies are lupus erythematosis, a complex disease characterized by skin rashes and lesions, affecting heart and blood vessels as well as kidneys; multiple sclerosis; chronic thyroid problems; some types of hepatitis and many other illnesses. The book is worth reading. It also exposes a

danger to women. In his epilogue, the author reveals where he is at when he says, 'The proposition that perhaps birth control by sterilization is better aimed at the woman finds some generalized acceptance even among those working hard to make vasectomy an honorable and widly used contraceptive procedure.' (Particularly Fried.) The book reveals an undercurrent of hostility toward women.

After you read Vascotomy you may want to write Cardinal Cook a letter saying you support the church's anti-fucking stand. Don't expect Him to publish your note, however, the way he did with his pen pal from Washington.



men aspire to today. Many women who disdain the uselessness of their white counterpart never-theless spend most of their inadequate paychecks aping the stereotype of their white sister, and become additional members of that vast army of women who have worn themselves out working to live up to the "feminine ideal." No woman invented that stereotype.

At this moment in history, many white women have finally paused to take a long look at their situation and evaluate the part they have played not only in their own oppression, but in the op-pression of others. Yes, she is coming from a different direction, and no, her struggles have not been what ours are. But this in no way innot been what ours are. But this in no way invalidates the legitimacy of her struggle any more than her personal woes invalidate the genuineness of ours. It would be ludicrous for the black woman to now reverse roles with the white woman. And yet many of them seem determined to jump on the glamor treadmill to futility, attempting to emulate Essence Magazine's moist-lipped, dewy-eyed pussycat. I wonder whether the black revolution is being fought so that we black women can lounge around on the sidelines in our thigh-high boots and purple eyelids pretending helplessness and femininity, while waiting to helplessness and femininity, while waiting to enter the next bathing beauty contest--at last, the pedestal!

Man's superior attitudes towards women are so entrenched and insidious that the black man is no less victim of its destructiveness than any other male. Since he has not been excused from other male. Since he has not been excused from machismo conditioning since childhood, he cannot be excused from confronting the ugly truth of his chauvinism. "Racism and chauvinism are anti-people," claims Cade, and a brother "cannot be politically correct and a chauvinist too." It is time to crack through the veneer of our hallowed definitions of masculine and feminine, and recognize them for the symbols of dominance and submission that they truly are. As a black woman, I am weary of the public insults and subtle degradations I am forced to take as a daily routine from all men-the white who approaches me with a contemtuous arrogance that implies it is his prerogative as white male to proaches me with a contemtuous arrogance that implies it is his prerogative as white male to abuse me as he chooses, and the black who, after hassling me on the street, spits in my face, "Speak when you're spoken to, woman!" Does anyone dare ask me to measure which brand of chauvinism is more contemptible; more

dehumanizing?

We are told by the brothers to let them 'look out for the race.' But who's watching our black male capitalist as he fattens up and becomes entrenched in the very system that has conspired to destroy us? Who's watching him as he elbows his way into the power structure and nibbles at the fat white dollar? He soon will have as many reasons to keep women and the poor on the bottom of the heap as his white male counterpart. There is profit to be made in exploiting the black woman's fears and anxieties to finally the long, and all ready both with white will be soon. black woman's fears and anxieties to finally 'belong,' and all ready both white and black male entrepeneurs are moving in on it. All ready her body is replacing her white sister's in the slick ads, tantalizing her with the ''good life' she's missed. And notice how after the outcry of ''racist putdcwn,'' the face of Uncle Ben came off that box of rice, whereas Aunt Jemima has merely been glamorized, and given youth and a new hairdo. To perpetuate the image of the black man as servile is unspeakable, yet the depiction of the black woman in a lower status is still perfectly acceptable. For the benefit of the male fantasy, black and white alike, she's simply been turned into a more glamorous maid!

We have been hearing so much about "standing behind" our man-be his moral backstop, his moral support. That human beings should be supportive to those they love and who love them is without question, but the society we should be working toward is one where people do not require others to serve as their principle props.

I can't push a black man into growth for himself. I can't live his revolution for him. He has to do it." And Woman has to live her revolution. The women's movement is working toward a trans-formation of human values where we can finally generate a society where no race or sex believes its progress or self-interest is dependent on the denigration of another. ..a society where I can be Up, but you don't have to be Down...where we can both truly be free.

Mother Courage, at West 11th and Washington Streets, is owned and fed by two feminists, Jill Ward and Dolores Alexander. They raised the money for their enterprise by selling guaranteed bonds, which come due next year. From where I was sitting it looked like that would be no problem, as business is brisk.

The decor is determinedly unaffected. One medium-sized room with tables relatively close together make it easy for feminists to meet, greet and gossip during courses. The unclothed,

and gossip during courses. The unclothed, plainly varnished tables, lit overhead by New Jersey surplus street lamps, are an interesting contrast to the profusion of lush plants in the windows and the original art displayed on the walls. While waiting to be served, I

School System Flunks 'Equality Regents'

The New York State Board of Regents has charged the state's educational system as 'clearly responsible for perpetuating discriminatory at-titudes toward women.' In a position paper issued in May, it reported that while women were 58.7% of the professional staff of public schools, only 21% of elementary school principals were women. Outside New York City, there was only one female school superintendem and one district principal in the state. The Board urged affirmative action, calling for priority for qualified women in the appointment of superintendents, principals, college presidents and deans.

These days, the Mother Courage menu is dis played on a blackboard upon the brick wall. A feature of the restaurant is to always have at least one very inexpensive offering, such as chile (\$1.50) or meat balls and spaghetti (\$2.00). Other offerings, more unique and more expensive are available, such as spinach salad (\$2.25), moussaka (\$2.75) and beef stroganoff (\$3.25). Last night I began with a delicious specialty of the house, the Mother Courage salad. The drestsing is the invented secret of Fran, the cook, and is only divulged to dedicated, time-worn, battle-scarred warriors of Women's Liberation. battle-scarred warriors of women's Liberation. I do not have it. The moussaka was tender and cheesy, down to the last pecan. The spinach salad was crispy, with lots of bacon and came with homemade sweet bread. The average bill at Mother Courage is approximately \$4.00. The restaurant does not have a liquor license, but one is encouraged to bring his/her own wine court one, wine-glass, and hottle-opener. one is encouraged to bring his/her own wine since courteous wine-glass and bottle-opener service is provided. The establishment is open from 6 P.M. to Midnight, and closed on Tuesdays. It is completely owned, run and dominated by women who know what they are doing and do it well. In fact, even the clientele is primarily female. Last night there were four and one-half males (one was a five year old) in a room containing about thirty people and one dog (Boris, attractive brown and white father of many). The service stops just short of being excellent because the waitress is often socializing with the customers.

The name 'Mother Courage' comes from the play of the same name by Bertolt Brecht. It is an apt name for a feminist restaurant, for Mother Courage herself was an enduring, long-suffering, peasant entreprenuer who sold her pushcart wares to the soldiers during the hard-

ship, cruelty and ugliness of a long war. Her most significant attribute is that of survival. She will survive and thrive, despite the odds.

FEMINIST THERAPY

Moving Towards "Me The Individual"

In the past few years many psychotherapists, mostly women, bove had their consciousness so raised to the needs of women that they have abandoned many of the traditional workings of existing psychiatric schools. Woman, particularly, need something unique from a asychotherapist. For therapy, until now, has been largely a reflection of our culture which imits female roles and choices. The influence of the new Feminust Therapists is being felt, and they are responsible for a growing awareness of the new feminism among psychiatric professionals. Most important, they are providing assistance to women who wish to become self-identified rather than male-identified.

The purpose of the new feminist therapiete is not to teach women to fit into the status quo, but rather to choose and create their own lives. Their aims are to help the woman client get rid of the conventional hanguage and begin to lead adventurous lives; to throw off the cultural missespresentations of what life should be, not what it gould be.

How do you find such a therapist? Referals for feminist therapists are available from many women's organizations such as The Women's Sentor, DCB, NCW, etc.

However, upon first moeting a prospective therapist, the dient should make certain inquivies, such as "What do you think is a women's highest fulfillment". If you get an answer that indicates whatever would personally fulfill the women, you have man a feminist therapist. If you are given an answer that indicates she should find her fulfillment through someone edse (nustand, children, etc.), you have not.

A Feminist Therapist recently gut it this way. "I have be-

come a Feminist Therapist because as both a woman and as a therapist it is necessary for me to continually question the role of women in contemporary society, and to be keenly aware of the inveraction between the self and cultural values. I see in the modern revolt against authority zuch hope. As science began we overthrew the gods and chance as determining factors in our lives; as the feminist revolution begins there is hope that we can overthrow sterectypes and the procrustian forcing of children into preconceived molds. Eventually, if our strength holds out, we may come to see each person as an individual, regardless of gender, intelligence, schooling, bank account or any other external factors, and to see ourselves instead as persons relating to individual persons. 'We the people' is certainly better than 'you the subjects,' but we still have to move to 'ME THE INDIVIDUAL.' And we must move quickly before we become numbers in an IB system. Hence we join with others, clients and Feminist Therapists, who share our views to encourage each other to be free - truly free to center our lives in ourselves, to make a free contribution to a healthy society, to love other persons of our own choice and to be actively engaged in whatever we choose to do. We need a sense of excitement about what we are doing. We need to die with the satisfaction of knowing that we have lived.

WHO IS SHE?



HERE SHE IS . . MS. AMERICA

It would appear that feminists are to Atlantic City what swallows are to Capistrano. We keep going back to the same place, but people never seem to get a clear idea of why we do it.

Bad press? This year it bordered on no press. Unless you count the handful of South Jersey radio stations that sent along their male reporters to get cute remarks from Ms. Women's Center, Ms. FOCAS, Ms. GWLF and others. We were not being cute that day, Sept. 11, on the boardwalk in front of convention hall. The dozen or so women who came down packed in two cars from New York, and the few who succeeded in hitchhiking (six women were picked up by Jersey police for attempting to hitch and had to take a bus back to New York) were solem, angry, as overcast as the weather ..

We handed out statements and leaflets explaining why we were protesting the pageant. It was one of the many ways in which men reduce women to sexual objects, and an institution designed to promote competition among sisters. We compared the pageant to a cattle auction and noted that women do not subject men to such degradation.

Feminist demonstrators soon found that they had to share the demonstration area with a group of veterans against the war who felt that the dehumanization of men in the war

was analogous to the dehumanization of women in a beauty pageant. They're learning.

Our first mistake was the bus problem. We had put a \$50.00 deposit on a bus without getting advance payment from the many, many women who said they were going to come. We depended on these women to show up on the morning of the action and they didn't. We had to turn the bus away because we couldn't afford the additional \$150.00. This meant squeezing all the women we could into one car (the other car had already left) and the rest of the women had to hitch.

Mistake No. 2: We had very few tickets to the pageant. They cost \$3.75 each and we didn't have the cash on hand. Seven nums of the Magdaline Order bearing a Sisterhood Is Powerful banner in a little black pocketbook were turned out of convention hall after they were found wandering around inside without ticket stubs. Their explanation, that a novice holding all eight stubs had taken sick and was probably in the ladies' room, was not believed by Atlantic City plainscloths police who, seemed to be everywhere inside the building.

Mistake No. 3: Our seven literal "Sisters" should have had a thorough knowledge of the floor plan of the hall, and a well-rehearsed plan of action. They should have appointed a spokeswoman and everyone else shut up when questioned, rather than giv unconvincing and conflicting stories.

Furthermore, nums were a bit conspicuous at a Ms. America pageant. They should have laid aside their habits for the evening and disguised themselves in the least noticable attire: saket, heels, sexy evening tactifis. As their nermal a matest and saintly selves they were inviting suspicious.

Mistake No. 4: When three wemen in impeccable lay attire succeeded in draping a Women's Liberation banner over a balcony in the manner of another banner with a less political message already hanging nearby, they ran down the stairs and a man who looked like an ordinary photographer but may not have been tipped off the police and security guards. When the women were pursued by police with guns drawn, two stopped, the other kept running. This was not wise, to say the least. The police had not been informed as to the triviality of the crime" committed. For all they knew she could have just stabbed somebody or worse still; stolen someone's PROPERTY. But even if they did know she had merely hung a banner, it doesn't mean they wouldn't shoot her for it. Our lives are more important that our arrest records. As it turned out, names were taken but no arrests were made, and the fugitive escaped unharmed.

But, the biggest mistake of all may have been going down there this year in the first place. The pageant itself is losing support for a number of reasons. Chiefly because it is a truckload of corn. Bert Parks is aging. The winner is always white, and racism is regarded as poor taste in some circles. There was extremely little news coverage of the pageant, never mind a disruption of it. We might as well disrupt a L-H fair, or a scout jamboree. Besides, our arguments are lost on the contestants who feel fulfilled in such activities as playing "Lady of Spain" on the accordion and growing their hair! The pageant fans still think we're just jealous because we're ugly, lonely, frigid or sick. cont.

We can do either of two things:
1. Give up Ms. America Pageant
and let it die of natural
causes. Use what we've learned
about effective zap action to
attack other institutions:
The Church, Vocational High
Schools, Ma Bell, the Healthocracy, Emanuel Celler, Playboy,
42nd Street, Pimps, etc., etc.

or

2. Those women who still feel Ms. America Pageants degrade women and deserve our continued attention, can return to Atlantic City next year; but only after long-range intensive planning, fundraising and publicity within the movement. No more halfway measures. We are too few to waste our efforts in disasters.

THE VERBAL RAPIST

Verbal Repist Bites The Dust

The "Verbal Rapist" and whether we should retaliate against him was the topic of the fourth FOOAS feminist forum, held on September 9 in P.S. 41. Despite the immediacy of the problem of street harrassment by men, the turnout was disgracefully small.

Speakers were Barbara Mehroff of the Feminists, Shelley Gross of the New York Chapter of NOW and Mency Borman of FOCAS. Besides their talks on the psychology and politics of the street pig, there were numerous suggestions by members of the audience for dealing with the problem.

A small thin woman startled the audience with the information that she habitually deals with obscene comments by punching the offenders in the face. They are too surprised to hit beck, she said.

A cab driver told the women that she found that Spanish men consider it the most serious insult to be spat upon. She waits for a green light and then spits in the verbal rapist's face as she drives on. Another woman tries to spit on a man's shoe. It's also considered particularly insulting.

The growing problem of men exposing themselves to us in public places it tackled by one woman with the following remark: "Look at that. It looks like a prick...only smaller."

Shelley Gross reported of dealing with oglers by stering at their crotches. They get very emburrassed and indignant. "Men are nore modest," she explained. She and other women also use this tactio: A man makes an offensive comment. The women rimes been with, "Your fly is spen." He usually sheeks.

Then she laught. She ow. all say, "Your fly is open and nothing is showing."

It was also pointed out that prostitutes are being arrested for the very same practice that men employ daily against women. Verbal harrassment. It's enough to get a women arrested for talking to businessmen in midtown, but women don't have men arrested for talking to them.

To de-escelate the verbal abusestreet warrare the suggested action was an organized and well-publicized arrest of a nan for all the charges that businessmen can bring against prostitutes: loitering, creating a public nuisance, harrassment, blocking a sidewalk, etc.

A dancer from Barbados suggested that the zep group of women, instead of trying to get the men convicted under the lew, merely beat the stuffings out of him end announce the reason for the action anonymously to the press.


There was a lot of enthusiasm for both schemes.


Health Conference Planned Mov 20







prostitution and the woman's movement

BEDFELLOWS MAKE STRANGE POLITICS

There are "good girls" and there are "bad girls" but they are not very different from each other. The good girl is a regular, dutiful, unsalaried worker for a particular male. The bad girl, on the other hand, is an irregular, dutiful, well-paid worker for a variety of males. Neither woman has had a real choice to another style of life. Both girls are dutiful. The good girl is called wife, the bad girl is called prostitute.

Prostitution (and homosexuality and gambling besides!) was the subject of three days of hearings held September 13-15th by an ad hoc state legislative committee on "victimless" crimes. The purpose of the hearings was ostensibly to gather information from "the experts" and to sponsor legislation as a result. The motive for all this apparent effort, besides "cleaning up" the mid-town area of

prostitutes, was publicity.

The hearing room at the Association of the Bar of the City of New York, 42 W. 44th Street, was wood-panelled, carpeted and curtained. When I arrived, it was about half full of people. Although chairs were still plentiful, it was difficult to sit in one because the press photographers had wedged them together to make room for tripods and snakey electrical cords which criss-crossed the room. After the press, came the feminists, over twenty of us from various groups. After the feminists, the invited speakers were represented, 6 or 7 men carrying their expert testimony. Finally, came the two hosts and thir NOW-looking secretary, isolated along the edge of a long oak table at the front of the room.

With the single exception of Gail Sheehy, all the invited speakers were men. (Only men are considered by other men to be experts -- regardless of the subject.) Susan Brownmiller had called to put her name on the speakers' list, but had not been invited. Around llam.

She pointed out that prostitshe spoke. ution is not a victimless crime; the prostitute is the victim; the crime is that the victim is prosecuted while the criminal act (perpetrated by men) of purchasing another's body is not prosecuted. The laws on prostitution are clearly designed to protect the criminals. Susan then introduced another woman, the next on a list of around 15 uninvited speakers. During all this, and Olivieri appeared either vaguely amused or seemingly grim while stabbing a ball pen at their writing pads. The next speaker called for the decriminalization of prostitution by the repeal of all prostitution laws. She opposed the decriminalization of prostitution by the legalization of prostitution. Legalization would lisence prostitutes and require their inspection, thus insuring top quality meat for the customers. Solarz and Olivieri could not stand any more. They had invited real prostitutes to testify and would we interrupt our list of speakers to allow them to speak. Of course we'd hear the sisters.

Barbara Hart was an (ex)callgirl. assemblymen had invited her to testify and she had prepared a statement to read for them. However, because we were there she decided to speak without the text. While she was talking, she was carefully listening to our remarks. She called us sister. We called her sister: But her testimony was ambivalent. She was prepared to say only that prostitution is the fault of women. (That's like saying war is the fault of hand grenades.) But, because of our presence, she came out with: "Women need more personal freedom within marriage and this will do a great deal to stop prostitution." (A radical feminist position if the words "within marriage" . are ommitted.) She said that prostitutes suffer from a double standard: the man likes them, offers them money, but at

home later, tells his wife (fellow legislators, fellow judges, fellow speakers, fellow policemen, fellow police commissioners, fellow mayors, fellow governors) how much of a problem prostitution is and how they have to crack down on the prostitutes!

Fran Christman, a former prostitute and current member of the Fortune Society took the chair. Assemblyman Solarz pointed out that Fran told him that some woman had called her to ask her not to testify. Why didn't he let Fran bring that up herself? Solarz tried to get us women fighting each other (a typical male divisionary tactic), to make it seem that we wanted different goals. Only we do not. Feminists and prostitutes agree: no legalization of prostitution.

Alix Schulman returned to the speaker's chair to give her testimony. read from an essay written in 1911 by Emma Goldman. Solarz interrupted. whould just give them the reference and the assemblymen would read it themselves. But, Alix protested, when the judge testified they didn't ask him to mail in his remarks. She said that Emma explained to men the origins and causes of the "prostitution problem" over 60 years ago and that the essay, therefore, was being presented as a lack-of-progress report on the topic. Solarz, with a smirk on his face waited impatiently for the testimony to end. (All in a day's work for our representative.) The next speaker stepped forward. Unable to listen to any more women, both Olivieri and Solarz interrupted saying that they intended on hearing only their invited speakers. We protested. They said we were "disruptive" (i.e., not in agreement with them on the issue of prostitution). Solarz said he would end the hearing unless we were quiet (i.e. did not give testimony, especially in front of the cameras). We explained to the gathering that Solarz was blackmailing us. Both assemblymen then said that there would be a 5-minute recess for them to talk with the invited speakers. . They caucused in front of the long oak table. The press photographers slowly pulled out their equipment and coiled the snakes. The assemblymen decided to recess for a further 45 minutes, and to take the invited speakers to lunch and finish the hearing there, in private.

They started to leave the room. We followed them out on all sides. We refused to allow testimony of men to men on an issue about women, expecially after they had failed to take seriously what testimony we women had already given. We challenged their right to call private hearings when they had been public, a move obviously designed to prevent the participation of us women. We told the assemblymen that we would attend lunch with the other speakers and hear their testimony. When it became clear to Olivieri and Solarz that we meant to stay, they halted in the corridor outside. They said that they would hear our testimony tomorrow, because the invited speakers had gone to a lot of trouble to attend and that they (the speakers?) didn't want to spend all day. But some of us had arranged for baby sitters, we protested, as well as going to a lot of trouble to attend. Apparently, to them, only men's words are important, only men's efforts have a value. They would hear us today. They would not! They would! The assemblymen decided they were going to lunch with their invited speakers in the Harvard Club across the street. We would go as well: it didn't matter to us that women weren't allowed in all the public rooms of the club. When they realized that our persistence would jeporadize Olivieri's membership, they decided against that course of action.

A woman passerby stepped out of the growing crowd on the sidewalk. Why won't you hear the women, she asked. You should should hear their testimony. Who are you to mediate, Solarz scowled. The answer: a democrat, a worker in the party, from your district in Brooklyn. Right on, sis-I thought she was from OWL (Older Women's Liberation), but she was a housewife from Brooklyn. Metamorphosis: a smile from Solarz, the first since we feminists began our testimony. An awkward handshake through the crowd. The invited speakers, with the exception of Gail Sheehy, were re-scheduled to speak the following day or to send their prepared statements to the assemblymen. Some of us lunched with the hosts, doing some

consciousness-raising over the table. We paid our own checks, refusing to allow ourselves to be bought and not even wanting reparations.

The afternoon crackled with testimony. Lynn Vincent reported that 4% of the prisoners in New York State are women, and most of them were "in" for short term and for sexually-based crimes. But, she pointed out, few men are in prison for sexual delinquency. She called for the repeal of all prostitution laws, and in the mean time, for the arrest of the pimps and johns.

Who are the johns? In the stormy morning session, Susan had quoted Kinsey as saying that 80% of American men turn at least once in their lives to prostitutes. That's a very high percentage: it's got to include most of the men you and I know and most of the men we see in the street and in the news. That 80% would, of course, include governors, mayors, police commissioners, policemen, judges, and legislators. Is it really any wonder, women, that the pimps and johns go free?

Solarz had to leave for a political gathering. Olivieri looked panicky. Solarz picked up his empty note pad and, with a smirk on his face, walked out of the hearing room. A few calls followed him out. Apparently he feels that the male vote is enough to re-elect him. Olivieri was the only man left in the room. He sat, slouched in his chair, with a pained look on his face as we continued our testimony.

Pam Kearon from The Feminists, talked about male power. Prostitution is often blamed on us (married) women because we don't look appetizing enough to the husband. Presumably, husbands have this unexplained need for a sexual variety and they go to prostitutes because of it. However, Pam pointed out, only 40% of American women, according to Masters and Johnson, have ever had an orgasm. (A what?) Men have such a need for sexual variety, but are unable to satisfy even one woman! Why, then, does a man's masculine image to other men depend on how many women he "handles"? Sexually, most men can't "handle" even one woman in the right way. Pam stated that prostitution is not the result of male sexual expression, but is, rather, the expression of male power. As a further example, she noted: "There's the good girls and the


bad girls (both of which are defined by men by how they relate to men) and when we suddenly got into the hearing room, the good girls became the bad girls and the bad girls became the good girls." That male power!

Most of us doubted the motives of the assemblymen in holding the hearings on prostitution because of all the political power men currently have. Eighty percent of American men turn at least once in their lives to prostitutes. Unfortunately, all those men have a problem with prostitution: they take a chance of giving each other verereal disease (VD) through using the prostitutes. The way for them to avoid that nasty possibility is for them to legalize prostitution. That would necessitate the lisencing of the women and their regular inspection to make sure that they've cleaned themselves after use. In that way, the customer would be assured of purchasing N.Y.Gov't inspected meat from the grocery store. Do you mean to tell me that those male legislators want facts to decide on whether or not to legalize prostitution?

Oppose the legalization of prostitution. We women are 53% of the population in New York. We are 60% of the voters. The male vote is not enough to elect our representatives. Write to Antonio Olivieri, 112 E.74th. St., N.Y.C. 10021 and to Stephen Solarz, 1818 Avenue U, Brooklyn, N.Y. 11229.

RAPISTS MUST NOT GO FREE

Rape Statistics and the Law

Forcible rape is the most frequently committed crime of violence in America today. In 1969, 36,470 rapes were reported in the United States. However, rape is the most unreported of all crimes. Criminologists estimate that less than one rape in ten is reported to the police. This means that in 1969 alone, men committed more than 360,000 rapes.

As if this were not bad enough, the number of rapes reported is increasing every year. In 1969, rapes were up 17% from 1968 and 116% from 1960. In ten years the number of rapes reported has more than doubled.

What are the courts doing to affect the rising tide of rapes? They are acquitting rapists and putting them back on the street again. In New York State 1,840 rapes were reported in 1969. Only one of the rapists was found guilty by the courts.

What gives the courts the license to return rapists to the streets? That hallowed institution--THE LAW.

Although rape has the appearance of being illegal and women reasonably expect protection from the rapist under the law, the men who make the laws are more concerned with protecting the rapist from the woman he attacked.

Men like to pretend that women accuse men of rape without reason. To safeguard themselves against our unfounded accusations, the New York State law provides that a woman's testimony against a man is not sufficient to convict him of rape. She must produce additional or corroborating evidence--usually a witness. No other crime requires the victim to produce such evidence.

Also, if the rapist has a previous record of rape, this record cannot be used against him in court. However, if the woman he attacked is said to have a bad reputation this is admissable evidence against her.

Are Rapists Sex-Starved Maniacs?

According to Menachem Amir's new study of 646 rape cases in Fhiladelphia,

men who rape are not crazy or starved for sex. Rapists are as normal as other men. Since they are not different from other men, how can we tell who is a rapist and who is not. We cannot. Every man living is suspect; even the men we think we know so well. In one-third of the cases studied by Amir the rapist was one of these close male acquaintances.

Meither are rapists poor sex-starved men suddenly overcome by their passions. In three-quarters of the cases studied by Amir the rapists planned the rape in advance often with an accomplice or a gang of them.

Criminologists have exploded another myth about men's sex crimes. Men do not remain exposers and peeping tems for life. When they learn they can get away with these crimes they progress to worse crimes, which semetimes culminate in murder.

Who's Protecting Who?

Rape is an act of violence committed by any man against any woman. Even though the woman is not beaten and killed every rape carries with it this threat. Every girl, every woman throughout her life lives in fear of rape. As she walks down the street at night, goes to the movies, comes home to her apartment, she lives with the certain knowledge that she can be raped by any man.

This fear serves men well. It makes women turn to men for protection from men. Susan Griffin writing in RAMPARTS has called this a protection racket. Men's protection racket usually means marriage, which is popularly believed to protect women from other men. However, marriage gives a woman's husband exclusive rights over her body, including the right to rape her. In New York State law, the raped woman is defined as a female person not married to the rapist.

It's Against the law to Defend Yourself

Although the law does not presecute men for rape, predictably it prosecutes women when we try to defend ourselves against rapists. One woman in the Woman's Movement once served a six-month jail sentence for defending herself against rape. Though the rapist had a long history of rape and child molestation the court ruled this evidence inadmissable. So the rapist went free, while the woman he attacked went to jail!

However, even though we are punished for defending ourselves, we are nevertheless required to prove we struggled violently against the rapist. Otherwise, we are accused of inviting rape. As one male defense lawyer put it "Consent no matter how unwillingly given is still consent."

A Call to Action

The courts are letting rapists go free. The rape laws are making it easy for them. The Women's Movement must work for new rape laws which will severely punish rapists, not protect them. We must put pressure on the police to apprehend rapists and on the courts to prosecute them. We must report all rapes and press charges against the rapist. Men must know they can no longer get away with this crime against women.

general assembly


Minutes of the Last General Assembly 9/9/71



SEE WH.T'S MISSING AND FILL THE GAP--FORUMS AND DISCUSSIONS -- CLASSES -- Groups could organize forums, discussions, or classes on anything of interest. In order to schedule a meeting all you have to do as find a blank time on the calendar and write it in. You can get a group together by posting a notice on the bulletin board. If you need some advice attend a Steering Committee meetin;. JOIN A CENTER COLLECTIVE -- Some that exist, but barely: Financial, Literature (choose & order), Speaking. Speaking is really a good thing -- two or more women (or a whole CR group) go to all kinds of groups requesting speakers on Women's Liberation. You get to talk to a lot of women and turn them on. Please help out the few hard working women who have been killing themselves to keep these going. Some collectives that used to be but are no more: Carpentry, Forum, Fundraising, Frinting (we have an offset press), Library, Information. COME TO GENERAL ASSEMBLIES, STEERING CHMITTEE MEETINGS -- All policy is decided at General Assembly meetings, including whether all policy should be decided at General Assembly meetings. All interim decisions are made by the

Steering Committee.



The Women's Center is a leaderless community. It's you and me and other individual women we know and don't know working cooperatively to create something for ourselves. This is no glib statement—the services provided by the Women's Center and the activities taking place here and everything else that goes on here goes on because you or I wanted it. Because and only if you or I started it and/or kept it going. If something's missing it's because you or I don't want it bad enough.

The Center has only two part-time paid staff members.
