Dear Sisters and Friends,

We're sorry you haven't heard from Los Angeles Wages for Housework sooner. This National Edition of our newsletter is a composite one and includes some articles which you may have seen in earlier issues. Many of the articles are new, and you may be particularly interested in the back page which discusses some of the organizing we have done in California around the abolition of all laws against prostitution. We apologize to you that the newsletter is in English only. We haven't had the time or money to have it translated and reprinted in Spanish. We hope to have that available soon. Contact us if you need the Spanish newsletter.

We would like to explain why this issue of the newsletter has been so long in arriving. We have been very busy deepening and extending the Campaign for Wages for Housework. With all the cutbacks and propaganda about shortages, it is essential now to organize our power to protect the money that women have already won for our work and to fight for more. We really felt the power of the Campaign to make that fight when about 100 of us gathered in Chicago for a North American WFH organizational conference in April. Black Women for WFH spoke about the power that the struggle of welfare mothers has brought to all women, and about how we are organizing to defend that money. Beth Ingber from Los Angeles discussed the stepped-up harassment of prostitute women as an attack on our access to money of our own. She described the mobilization we have undertaken in support of prostitute women.

Here in Los Angeles, we will be putting the government and business on trial for pimping (see enclosed leaflet). We are holding similar trials in San Francisco and Boston; other street events demanding the abolition of all laws against prostitution will be held in New York and London. We are charging government and business with "Pimping off of Prostitution and Pimping off of All the Work Women Do." We hope you will come and testify about the ways government and business profit from the work you do! The "trial" will be held in MacArthur Park on Sunday afternoon, May 15th. We intend to enjoy ourselves while we make our point, and hope you will join us. If you can use more leaflets to post or to give your friends, please call us at 680-1767.

We are also planning an open house on Thursday, May 26th. It will be an informal occasion -- a chance to discuss the trial, ask questions about the Campaign, and relax together. All women are invited.

We look forward to seeing you at the street trial on May 15 and at our party on May 26th.

#### BLACK WOMEN'S GROUP FOUNDER WILL SPEAK IN LOS ANGELES

A series of events featuring Margaret Prescod-Roberts, founding member of Black Women for Wages for Housework and of the Queen's College, N. Y., Women's Action Group, has been planned for her 7-day visit to Los Angeles.

Arriving here from San Francisco on Tuesday morning, May 10, she will address a special 12 noon meeting of the UCLA organization, Women Against Cutbacks, in the conference room of the North Campus Facility. "All women, as well as student, staff and faculty women, are invited to hear her," said Beth Ingber, spokeswoman for the International Wages for Housework Campaign.

On Sunday, May 15, Ms. Prescod-Roberts will be a star witness in a street trial charging government officials and business with pimping off of prostitution and of all the work that women do. The trial, organized by the Los Angeles Wages for Housework Committee and Wages for Housework—San Francisco, will take place in MacArthur Park between 3 and 5 p. m.

She will participate on May 16 in a WFH meeting in the Mayor's office at 1:30 p. m. and in a press conference called by the West Coast WFH groups, to take place immediately afterward.

Climaxing her visit will be An Evening with Margaret Prescod-Roberts, at 7:30 p. m., May 16, at 2046 Garth Ave. in Los Angeles, where her hostesses will be the Los Angeles WFH Committee. 

# Margo St. James: Housewives deserve pay

the fight to organize prostitutes and lend dignity to their work, is in Chicago to help housewives do the same thing.

The lean 39-year-old, who formed a group called Coyote, (Call Off Your Old Tired Ethics) to legalize prostitution, will speak at the first public meeting of the Chicago Wages for Housewives Collective at 7:30 p.m.

Chicago wages for Housewives Collective at 7:30 p.m. Friday, in the Loop YWCA, 37 S. Wabash. And one of the first things on the agenda is a reading from the Women's Declaration of Independence, which demands wages for housework for all women from the federal Conference.

The declaration begins, "We, the women of the United States, are fed up. After 200 years of American' Independence, we are still overworked and underpaid. We are still not independent."

"BUT THAT DOESN't mean that every wife has to charge her husband a fee every time she runs the vacuum cleaner or gives a sexual favor," Ms. St. James stated, running a hand through the dark straight hair cut in bangs across her forehead and chopped bluntly at her shoulders. "The point of this meeting is to have all her shoulders." her shoulders. "The point of this meeting is to have all women, including housewives and prostitutes, work together for independence and power, which come from earning—and keeping—money. Until now, men have isolated and exploited both groups of women. Wives did whatever their husbands told them to, because they were afrald that if they didn't their men would go to rectifying Now they are heginning to realize that by

were afraid that if they didn't their men would go to prostitutes. Now they are beginning to realize that by uniting, all women can demand that their time be valued, including the time given to sex."

She grinned, tossed her head defiantly and added, "After all, wives perform the same jobs prostitutes do—although most wives don't do them as well because of lack of practice and training."

Ms. St. James also stressed that, "An attack on welfare women, or on prostitutes, is an attack on all women—keeping us in line; to keep us all working for nothing. We women are pitted against each other as if our problems and our work were not the same." our problems and our work were not the same."

TROUGHTFULLY, she added, "The average house-wife who works 30 years in her home is certainly entitled to social scurity for her work. Some economists

Narrowing her intense dark eyes, Ms. St. James insisted, "Business makes money off our sexuality. Destroyed by the work they have to do, men come to us for the sexual and emotional gratification they need to heap weeking." keep working... More and more women are refusing to be exploited—to work at home free, and to work

to be exploited—to work at home free, and to work outside the home for low pay. Wherever we are demanding our wages, from the welfare department, in the street, or at a job outside the home, we're fighting for money for all our work."

She sighed, "Prostitution is one way of getting our wages, and in a way, all work is prostitution and all women are prostitutes, forced to sell their bodies for room and board or for cash, in marriage, on the street, in typing pools or in factories."

AND THAT'S WHEN Ms. St. James confessed that she hasn't "turned a trick" in 12 years. "Since I've been enlightened, it would be a humiliation. If a man wants to buy me, he has to buy my philosophy. I don't sell my body anymore

## Women Profest on Arrest

More than 50 chanting women picketed the Hilton Hotel yesterday to protest the beatings allegedly given a young woman and a taxi driver by plainclothes vice squad officers


During the 75-minute demonstration sponsored by a dozen women's organizations, demands were made for the immediate suspension of a policeman and an official commendation for the cabile

The focus of the affair was the arrest for prostitution of Janet Phillips, 23, by Officer Craig Piro at Geary and Jones streets on March 25

She suffered several facial fractures during a beating she said she received in a holding cell in the Hilton basement. David Taboe, 46, said he was punched and kicked unconscious in the cell after rushing to Phillips' defense on the street in the belief she was being attacked by a mugger.

"There hasn't been a real bad incident like this in about three years," said Margo St. James of Coyote, the organization of hookers and other "loose women."

She said the beatings were an outgrowth of a get-tough approach toward prostitution inaugurated when Police Chief Charles Gain returned the hard-bitten Captain

Gerald Shaughnessey to the head of the vice squad.

Shaughnessey, St. James said, has restored a number of "sadists" to the squad who had been transferred out because of civilian complaints about their behavior. "They think that if they make an example of one woman, the others on the

street won't get too uppity," she said.

Del Martin, the co-chairperson of the city's Commission on the Status of Women, said she has little faith in an investigation into the incident now under way by the police department's internal affairs bureau.

"They usually whitewash the officer," she said.

The women demanded the "immediate suspension" of Officer

Martin said the incident emphasizes the need for an office of citizen complaint staffed by civilians to investigate cases involving alleged police brutality. She said the Police Commission is "reneging" on an earlier promise to create such an office.

Diana Russell, a sociology professor at Mills College who wrote the book "Crimes Against Women," said, "I came down here to protest what I see as the escalation of violence against women."

Like many interviewed, Maureen Rafferty of a group called Wages for Housework said she believed the beating of Phillips was meant to carry a message to womenkind.

"Money is power and we don't have any power," she said. When women try prostitution as a means of earning money, they are subject to beatings and other pressures to return home, she contended.

"We're not going to be poor and respectable anymore," she said. "We're going to go out on the streets if we want to."

ing society's dislike of prosti-tution.

But it is not just prostitutes

But it is not just prostitutes who suffer, she said. All women suffer, among them women who work at low-paid jobs. "You suffocate us with paper, typing and filling, you defend us with dictaphones, and you bury us with bedpans and backaches," she said.

"But no matter how hard you try, you cannot kill our struggles. You cannot escape our accusations. We know who

our accusations. We know who you are international.

"You are General Motors, the phone company, the hospitals, the banks, the oil companies, the agribusinesses, the advertising industry. You are the corporations whose profits and power depend on pimping off of the work of our minds and bodies."

## **WAGES FOR HOUSEWORK** PLANS MOTHER'S DAY TRIAL



The International Wages for Housework campaign plans a simulated trial followed by a demonstration, in coalition with prostitute groups, in Hollywood on May 15th in honor of Mother's Day.

The recent increase in the harassment

of prostitute women in Los Angeles, of prostitute women in Los Angeles, San Francisco, and internationally is part of an attack against all women. The trial will be Women vs. Police Chief Ed Davis, City Attorney Burt Pines, Judge Wilbur Dettmer, Mayor Tom Bradley, Governor Brown, President Carter, General Motors, and John Does 1-50.

The demonstration is planned to show how government and business "pimp" off the work which all women do, whether they are housewives, prostitutes, women on welfare, or wom-en in the "caring" professions—nurses, teachers, waitresses, and domestic workers.

According to Beth Ingber, spokesperson for the Wages for Housework group, the government considers the prostitutes easy targets because they

feel the prostitutes are an isolated group without support from other groups in society. If women could get decent wages for work, prostitution would automatically be reduced. As long as men have the money and we don't there will be prostitution.

What society calls femininity is simply women who serve other people. Because housewives work for nothing, women who work outside the homes are devalued and forced to accept lower

wages than men.
Women's work in the home benefits business and government. They maintain the households and take care of families in order to free men from the time and energy required to do these things. Government and business benefit from this, and our labor is exploited without pay or recognition. They prefer us to stay home and work for nothing, remain consumers for this society, and not to compete on the job market.

## GUILTY VERDICT EXPECTED AT TRIAL FOR PIMPING

Another "guilty" verdict is expected here Sunday afternoon in MacArthur Park, when women try government officials and big business on charges of pimping off of prostitution and off of all the work women do.

The street trial will be the second to be carried out this week by West Coast Wages for Housework groups, with the support of more than a dozen other state and national organizations.

In San Francisco all defendants were found guilty and were sentenced to spend eternity doing unwaged housework, according to Beth Ingber, spokeswoman for West Coast WFH and the International WFH Campaign.

Star witnesses in Los Angeles will be Margo St. James, founder of COYOTE (Call Off Your Old Tired Ethics), and Margaret Prescod-Roberts. co-founder of Black Women for Wages for Housework.

Ms. St. James will name as pimps specific businesses and will detail how government takes its cut. Ms. Prescod-Roberts will single out President Carterand the head of the department of Health, Education and Welfare as pimping off the work of Black Women, particularly welfare mothers.

"All women are invited to attend the Sunday event and to testify how government and business pimp off their work," Ms. Ingber, who will act as prosecuting attorney, said.

The trial will take place in the section of MacArthur Park near Park View St., between 7th St. and Wilshire Blvd.

Dear Sisters and Friends,

We're sorry you haven't heard from Los Angeles Wages for Housework sooner. This National Edition of our newsletter is a composite one and includes some articles which you may have seen in earlier issues. Many of the articles are new, and you may be particularly interested in the back page which discusses some of the organizing we have done in California around the abolition of all laws against prostitution. We apologize to you that the newsletter is in English only. We haven't had the time or money to have it translated and reprinted in Spanish. We hope to have that available soon. Contact us if you need the Spanish newsletter.

We would like to explain why this issue of the newsletter has been so long in arriving. We have been very busy deepening and extending the Campaign for Wages for Housework. With all the cutbacks and propaganda about shortages, it is essential now to organize our power to protect the money that women have already won for our work and to fight for more. We really felt the power of the Campaign to make that fight when about 100 of us gathered in Chicago for a North American WFH organizational conference in April. Black Women for WFH spoke about the power that the struggle of welfare mothers has brought to all women, and about how we are organizing to defend that money. Beth Ingber from Los Angeles discussed the stepped-up harassment of prostitute women as an attack on our access to money of our own. She described the mobilization we have undertaken in support of prostitute women.

Here in Los Angeles, we will be putting the government and business on trial for pimping (see enclosed leaflet). We are holding similar trials in San Francisco and Boston; other street events demanding the abolition of all laws against prostitution will be held in New York and London. We are charging government and business with "Pimping off of Prostitution and Pimping off of All the Work Women Do." We hope you will come and testify about the ways government and business profit from the work you do! The "trial" will be held in MacArthur Park on Sunday afternoon, May 15th. We intend to enjoy ourselves while we make our point, and hope you will join us. If you can use more leaflets to post or to give your friends, please call us at 680-1767.

We are also planning an open house on Thursday, May 26th. It will be an informal occasion -- a chance to discuss the trial, ask questions about the Campaign, and relax together. All women are invited.

We look forward to seeing you at the street trial on May 15 and at our party on May 26th.

Dear Sisters and Friends,

We are writing to bring you up to date on plans for our street trial here in L.A. We will be charging business and government with pimping off of prostitution and off of all the work women do, and Margo St. James of COYOTE will be our star witness. The event will take place in MacArthur Park on Sunday, May 15, 3-5 PM. (See enclosed leaflet.)

We have already gained a victory in San Francisco! Supervisor Francois has "spontaneously" decided to call a public hearing on a resolution to the California State Legislature that prostitution be legalized. The proposal for a public hearing came shortly after WFH led a delegation of women to San Francisco City Hall. In our message to the San Francisco Board of Supervisors on that day, we expressed women's support for the struggle prostitute women are making to abolish the laws against prostitution. (Details were in our last letter.) We oppose Francois' resolution for the legalization of prostitution which would further institutionalize the government as the biggest pimp. But his resolution makes clear that when we women get together, we can make the government move, and we intend to keep fighting 'til we win what we want.

Our immediate response to the government's proposal for legalizing prostitution is to continue with our street trials charging the government and business with already pimping off of our work! Trials will be held in San Francisco, Boston and L.A. and other street events demanding the abolition of all laws against prostitution will be held in London and New York as well. We have received support for the L.A. trial from the organizations listed on the enclosed leaflet and we

are still receiving endorsements.

Your organization can still participate. If a woman from your group wishes to testify, please let us know as soon as possible. If you can post and/or distribute the enclosed leaflet, call or write us immediately to order the number you want. We still need money -- desperately. If you can send a donation, make out the check to Wages for Housework.

We hope you will publicize the trial in any way you can. AND COME ON MAY 15.

We're sure it will be fun.

## GOVERNMENT AND BUSINESS PIMP, WOMEN CHARGE IN STREET TRIALS

Charging specific government officials and big business with pimping off of prostitution, and all the work women do, the Los Angeles Wages for Housework Committee and Wages for Housework-San Francisco will hold two street trials-the first in San Francisco on Monday, May 9, and the second in Los Angeles on Sunday, May 15.

"Summonses" issued this week by WFH ordered the following to appear at the Los Angeles trial as defendants: Police Chief Ed Tavis, Judge Wilbur Dettmar, City Attorney Burt Pines, Mayor Tom Bradley, Governor Jerry Brown, and President Jimmy Carter, according to Beth Ingber, West Coast spokeswoman for the International Wages for Housework Campaign. "John Does 1-50 also have been charged," she said. Ms. Ingber will act as prosecuting attorney at both trials.

Star witnesses will be Margaret Prescod-Roberts, co-founder of Black Women for Wages for Housework and a leader of the Queen's College, N. Y., Women's Action Group; and Margo St. James, former prostitute who founded COYOTE (Call Off Your Old Tired Ethics) in order to organize prostitutes and lend dignity to their work."

Explaining why she is participating in the trials, Ms. Prescod-Roberts said, "The struggle of prostitutes is the same struggle Black women are making. It is the struggle to have the money--which is the power to be independent."

Other actions in support of prostitute women's efforts to decriminalize prostitution will take place during May in Boston, New York City and London, all under WFH auspices.

"All women are invited to attend the trials and to testify how government and business pimp off of their work," Ms. Ingber said.

The Los Angeles trial will take place from 3-5 p. m. in the section of MacArthur Park near Park View, between 7th St. and Wilshire Blvd. It is being held with the support of a dozen Los Angeles women's organizations.

#### WOMEN VS. BUSINESS & GOVERNMENT

#### (OPENING STATEMENT BY THE PROSECUTING ATTORNEY)

We women have come together here to charge, try, convict and sentence the Defendants for the crime of pimping off of prostitution and off of all the work women do. Those of us here can only begin to testify as to how, internationally, government and business grow powerful pimping off of our lives, and how the profits from pimping give them the power to force us <u>all</u> to prostitute ourselves again, daily, throughout our lives. But we need not call every woman to testify, because we are already speaking -- not only with our words -- but through the fight we are making to get these pimps off our backs.

It is fitting that we women are the prosecutors, the judge and the jury. How many times have YOU robbed us, raped us, and beaten us to force us off the street and back into the home to work for free -- with the force of law behind you? How many times have you thrown us in prison and taken away our children because we demanded that men pay cash for the sexual servicing YOU need us to do for nothing, because we demanded wages for the work you expect all of us to do at home for free, work that keeps men working so you can pimp off of them too. How many times have you jailed us and our children for hustling for money -- money that's ours, our money that you've got because you've pimped off of our work, because you've forced us to work for free or for pennies, because you've robbed us since we were born -- and you've robbed our mothers and grandmothers too.

And it is fitting that we try you and convict you because you are murderers as well, because pain and death are our working conditions. Daily, silently, invisibly, and legally, you kill us with endless years of work and worry, with endless housework for no pay and no power, with polluted air and polluted food, with industrial accidents -- in kitchen and in the sweatshop. You suffocate us with paper -- typing and filing, you deafen us with dictaphones, and you bury us with bedpans and backaches.

You kill us with endless forms and endless waiting and fighting for welfare and social security -- money that's ours by right, money that doesn't begin to pay for all the housework we do and all the work we've done. And all this waiting and fighting and worry is also work -- and you pimp off of that too.

And when we break down, when we're too sick to work, you doctors patch us up again to move us back on the assembly line. You patch us up -- for a fee, of course. Or you kill us with love -- your love of money, your love of cutting us up and cutting out our breasts and our uteruses. Or you kill us in your hospitals where nurses and aids, housewives like ourselves, are expected to make up with love the services you Defendants refuse to provide, are expected to care for too many of us in too little time, with too few facilities and for too little money.

And if you decide that you can pimp more off our death than off our lives, if we are not productive enough for you, if we are too rebellious, if we are too old and used up, if we live in Ethiopia and there are too many of us for the moment, you starve us. But our death is part of our work; it is a message to our sisters: Don't get out of line. Don't break down. Don't stop working. If we are Black or Chicana or if we live in India, you kill our unborn children. But if you need more workers for your factories and kitchens you try to turn us into baby factories — bribing us with compliments and morality, and when that doesn't work — and it doesn't — bribing us with money. In England, Canada and other countries you call it the family allowance. We know you are pimping off of our uteruses — but we take the money because it gives us power.

It is fitting that we try you and convict you because you are homebreakers -- legal homebreakers. By starving us at home, you force us to immigrate around the world. We follow the wage -- a low wage at that, because you pay us less because we are immigrants and vulnerable. And when you no longer need us, you call us illegal and push us back across the border, back to the wageless conditions you created and forced us to flee. And you are homebreakers because you kidnap our children if we are on welfare, or lesbian or prostitutes, that is, if we refuse to be dependent on men for money because we refuse the work and the powerlessness which is the price of that dependence.

And in your schools and through your media, you try to kill our minds and the minds of our children -- trying to make us accept that our work and your pimping are natural conditions of life.

But no matter how you try, you cannot kill our struggle. You cannot escape our accusations. We know who you are. You are the state and you are international. You are the welfare department, the schools, the police and the courts. And your job is to keep us working. You are General Motors, the phone company, the hospitals, the banks, the oil companies, the agribusinesses, the advertising industry -- you are the corporations whose profits and power depend on pimping off of the work of our minds and bodies.

And you cannot escape the judgement of this court, because internationally we have already condemned you. We have already begun to make you pay and there's nowhere to run to. We are everywhere fighting to take back our money so that we can take back our lives. And we say our lives, because wherever we are and whatever our situation, we spend every minute of our lives working, and we work from the day we are born to the day we die.

And you can't escape our sentence because we know you've got the money -- our money -- the money our work has created, the money you have pimped from us. We intend to prove today that you twins -- business and government -- are the biggest pimps. We intend to call witnesses -- full-time housewives, professional prostitutes, mothers, lesbian women, entertainers, clerical workers, all women -- to testify how we are all forced to prostitute ourselves to survive and how you pimp off of all our work. We will not let you deny us access to money of our own. We intend to demand the end to the harassment of prostitutes, the abolition of all laws against prostitution and amnesty for all prostitutes and the removal of all criminal records relating to prostitution.

And we intend to demonstrate how we are already carrying out the sentence against you, how Black women have led the struggle for welfare -- a wage for our housework, and how all of us are fighting for our wages. We intend to demonstrate how we are defeating you -- taking back our money, taking back our time, building our power to take back our lives.

Women call as our first witness Margo St. James. Will the witness please step forward and identify herself.
